All members are encouraged to vote. The deadline for voting electronically has been set as late as possible to allow you to meet the Western District candidates before voting. - Improving District responsiveness to the needs of our Sections and Chapters.

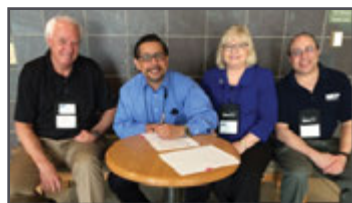
- Enhancing transparency and accountability for decisions and actions made by the District.

Transportation Happenings in Southern Nevada – How the Fuel Revenue Index is Fueling the Future of the Las Vegas Valley

How to fund, maintain, and build critical transportation projects is the focus of a conversation taking place not only in Southern Nevada but across the entire country. As the Southern Nevada community continues to modernize, grow, and diversify, the needs of transportation infrastructure demand more attention.

Ensuring efficient interconnectivity and mobility for more than two million residents in the Valley and 41 million visitors annually is paramount to the region's continued economic prosperity and sustainability. While costs for transportation construction projects continue to increase with inflation, budgets to complete road projects have not.

To cover this gap in funding, the Regional Transportation Commission of Southern Nevada (RTC) partnered in 2013 with local leaders, business community, state legislature, Governor Sandoval, and the Clark County Commission to support Fuel Revenue Indexing (FRI) to keep pace with material and labor costs, generate funds for critically needed transportation projects, and create jobs.

From January 2014 to December 2016, a portion of what drivers pay at the pump will help fund transportation projects throughout Clark County. For motorists, this averages about a dime a day over the three-year time period. This investment at the pump will generate approximately \$700 million to fund 199 projects in Southern Nevada, ultimately creating more than 9,000 jobs.

Thanks to FRI, 83 design and construction contracts totaling \$164 million were awarded by year-end 2014. Of these contracts, 53 were awarded to local small businesses, and approximately 2,121 jobs have been created so far. Not only is FRI improving roads and pedestrian safety, it is putting Las Vegas small businesses and residents back to work during a critical period of economic recovery.

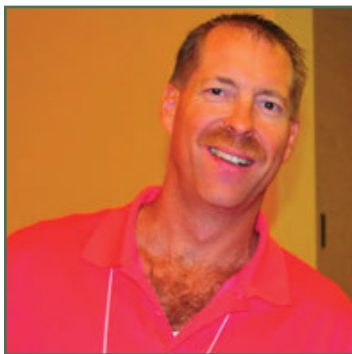

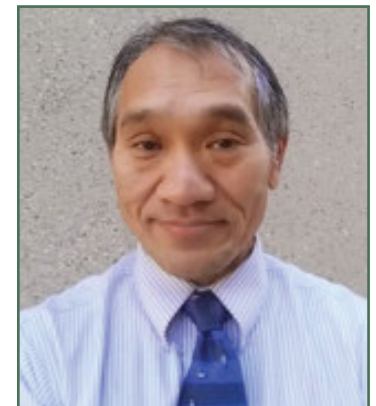

2015 Mid-Year Board Meeting Highlights

On Friday January 23, 2015, Western District Board members, committee chairs, section leaders, and guests met at the URS office in Oakland, CA, for the 2015 Western District Mid-Year Board Meeting.

President Carlos Ortiz announced the appointment of **Mark Greenwood** as chair of the Public Relations Committee, the re-appointment of **Joey Paskey** as the Managing Editor of WesternITE, the re-appointment of **Amit Kothari** as chair of the Technical Committee, and the re-appointment of **Dalene J. Whitlock** to the Advisory Committee. It was also announced that the District Administrator Review Committee evaluated three candidates, and that the Board selected **Dalene J. Whitlock** as the new District Administrator. **Ray Davis** was subsequently appointed to complete Dalene Whitlock's term on the Advisory Committee. President **Carlos Ortiz** also noted the new **Fairbanks, Alaska Chapter** and the new **Fresno State ITE Student Chapter**.

Vice President Cathy Leong provided a summary of the Fiscal Year 2013/2014 accounting, and noted that we have met our reserves target due to the return received from the 2014 Rapid City LAC. She reported that we went over the budget for travel last year, and in an effort to provide guidance on allowable expenses and to increase budget adherence, a Travel Policy Committee was formed and put together a new Draft Travel Policy. It was also reported that the potential net loss to the District from ITE International's new dues structure is estimated at about \$8,500 per year.

Secretary-Treasurer Mark Spencer reported on the District's year-to-date income (for the period of October 1, 2014 – December 31, 2014). It included the following: \$38,756.07 from the 2014 Annual Meeting in Rapid City and \$3,100.00 in advertisements. Year-to-date expenses have totaled \$27,731.48, including travel

expenses, WesternITE printing and mailing, 2015 and 2016 LAC advances, the website upgrade project, and a contribution to LeadershipITE.

Past President Karen Aspelin reported that she visited the Arizona Section to swear in officers. She reported that there was good participation in the nominations committee from the Sections and Chapters. The following candidates were announced: **Chuck Huffine, Dongho Chang** and **Lee Cabell** for 2015/2016 Western District Secretary-Treasurer; **Walter Okitsu** and **Justin Link** for 2016-2018 International Director.

The District's three International Directors, Jenny Grote, Jennifer Rosales, and Alyssa Reynolds Rodriguez, provided summaries of their recent activities. **Jenny Grote** announced that the ITE International spring conferences have been eliminated, and this year it will be replaced by a fall conference in Tucson, AZ. Also, **Tom Brahms** will be retiring and leaving ITE as of late fall 2015. A replacement search is underway.

ITE International Vice President Paula Benway joined the meeting via conference call. She noted that 2015 is ITE's 80th Anniversary! Also, there are two candidates for ITE International Vice President: **Shawn Leight** and **Jimmy Lin**.

WesternITE Managing Editor Joey Paskey noted we have done better with standardizing our publication dates. She indicated that WesternITE circulation is approximately 3,800. Our current policy is to produce two printed/mailed issues per year, plus an additional printed issue distributed at the Annual Meeting. The Annual Meeting issue helped reduce printing costs for the Rapid City LAC.

WesternITE Advertising Manager Robert Sweeting reported that the District has 20 advertisers in the Professional Services Directory and requests for renewals will be sent out in early Febru-

ary. For the fiscal year to date there were 15 positions available advertisements placed, up from nine last year. We have currently sold \$3,900 in position ads for this fiscal year.

Website Manager Justin Link provided an update on the website upgrade project. He highlighted the new website in a real time demonstration, and noted that it should be ready to go live in spring 2015.

Technical Committee Chair Amit Kothari provided a summary of his Board report and suggested that Board and Committee Chairs serve as student chapter mentors, in particular for data collection fund projects.

Membership Committee Chair Joe De La Garza provided a breakdown of the totals of members and membership types. In the last few years there has been an increase in voting members and a decrease in total members. Other professional organizations (YPT, WTS, APWA, etc.) are possibly drawing potential ITE members.

Legislative Committee Chair Tom Mericle reported that he has provided periodic updates for our website.

California State Bill 743 Task Force Committee Member Walter Okitsu summarized the report of the Committee. Tom Mericle noted that Eric Ruehr put together an analysis of how the change from LOS to VMT will affect transportation studies. It was noted that this task force has been helpful in representing the interests of ITE and our profession in general.

Career Guidance Committee Chair Neelam Dorman noted that we issued "First Time Attendee" ribbons for the first time at the 2014 Annual Meeting in Rapid City. Also, we may add a session for young professionals similar to what we did for students last year in Rapid City, which was well received.

Vendor/Industry Committee Chair Janna McKhann provided a written report, and offered to help the 2015 LAC with vendor coordination.

Student & Faculty Initiative Committee Chair Danielle Scharf summarized her written report and noted that the Student Traffic bowl had better questions this past year which led to a better event. Also, the pre-qualification round is now called Round 1, which makes the competition better.

Richard T. Romer Student Endowment Fund Committee Chair Kimberly Leung presented the status of the Endowment Fund; it is now over \$400,000. The SEF collected a lot of cash at the Annual Meeting, which was followed by additional fund raising via the ice bucket challenge initiated by Mark Spencer. There will be a booth at the 2015 Las Vegas Annual Meeting.

Public Relations Chair Committee Mark Greenwood reported that the update to the website is a great opportunity to roll out new social media initiatives. He suggested that the Las Vegas LAC have a session on how to deal with the media and public. This will help members that want to learn more about this topic.

Statements of interest for the 2019 Annual Meeting were received from the **Riverside-San Bernardino Section** (to host in Riverside) and the **San Francisco Bay Area/Central Coast Sections** (to host in Monterey). President **Carlos Ortiz** will invite both of the bidders to the 2015 Annual Board Meeting to make a presentation.

Rapid City 2014 LAC Co-Chair Randy McCourt summarized the final report for the Annual Meeting. A lot of cost savings came about through hitting the targets in our contract. The post-meeting survey was helpful. Keeping the meeting in one venue was cited as a key to success. Many new initiatives worked well. The col-

Most recently, the contract for the Boulder City Bypass, the first portion of the future I-11 highway connecting Las Vegas and Phoenix, was awarded, and construction is scheduled to start in May. Construction has also kicked-off on the Flamingo Road Improvement project, which will improve traffic flow, enhance pedestrian safety, and add dedicated transit lanes on this busy arterial.

Fuel Revenue Indexing is fueling the region's future by providing the necessary funds to move forward with transportation projects that will benefit thousands of residents and visitors every day – as well as support increased trade and economic development. The RTC and local jurisdictions are working together to advance projects that will improve commutes, enhance pedestrian safety, and create jobs to make our communities better places to live, work, and play – now and in the future.

laboration with the Midwestern District worked very well and can form a model for other joint meetings.

Las Vegas 2015 LAC Chair Lindsay Sundberg noted that there is a written report in the Board meeting packet that provides the status of the LAC planning. She thanked the Board for providing comments on the draft budget and Board report, and agreed to provide updates to the Board as the Annual Meeting dates gets closer. The Board reviewed and approved a budget and registration fee structure.

Albuquerque 2016 LAC Co-Chair Jim Barrera thanked **Randy McCourt** for a good and detailed 2014 LAC report that serves as a good guide. Their break-even budget is with 200 attendees. An updated budget will be ready for the 2015 Annual Board Meeting in Las Vegas.

San Diego 2017 LAC General Chair Joe De La Garza indicated that the LAC has conducted a more thorough hotel search to expand their options. Slightly increasing the hotel rate increased the geographic region and yielded more options. The current shortlist was noted, and the currently preferred hotel is the Hilton San Diego Resort. Some of the hotel amenities were then presented.

Breckenridge/Keystone 2018 LAC Co-Chairs Ben Waldman and Aaron Heumann noted that they looked at the Beaver Run Conference Center in Breckenridge as well as a property in Keystone, CO. The Keystone property may be a better fit for a Western District Annual Meeting. There is also some interest from TexITE to hold a joint meeting with the Western District, perhaps in Keystone.

The LAC Handbook revision project has been led by **Tom Mericle**, who summarized the draft of the revised document to the Board.

Student Leadership Summit Co-Chair Spencer Ord of Sacramento State University summarized his written report. Currently they have 100 students registered from four states. They have 25 sponsorships for \$18,000. **Kaylenn Roseman** of Cal Poly SLO noted she will provide more information at the 2015 Annual Board Meeting regarding the keys to continuity of the Student Leadership Summit.

A Travel Policy Committee of the Board met on January 22, 2015 in Oakland. The committee consisted of **Carlos Ortiz, Karen Aspelin, Cathy Leong** and **Mark Spencer**. Prior to the committee meeting a draft of the Travel Policy Update was sent to the full Board. Comments received to date were reviewed in the committee meeting. A revised Draft Travel Policy was distributed the full Board at the Board meeting. Following further discussion and edits, the revised Travel Policy Update will be considered as a Board Action Item at the 2015 Annual Board Meeting.

The meeting adjourned at 4:59 pm. The next Board Meeting will be held at the Planet Hollywood Hotel in Las Vegas, Nevada on Sunday July 19, 2015, at the ITE 2015 Western District Annual Meeting.

With the shifting of the spring technical conference to the fall, the typical fall International Board of Direction meeting is now in the spring at ITE Headquarters. **John J. Kennedy** presided over the meeting as International President, assisted by International Vice President **Paula Benway** and Past President **Hibbett Neel**. We were joined by the other nine District International Directors and the other two Directors who represent the Western District; **Jennifer Rosales** (from California) and **Alyssa Reynolds Rodriguez** (from Nevada).



The meeting started with two Washington Briefing Panels:

Challenges and Initiatives for the Transportation Profession

These panels provided valuable insight to issues that impact transportation policy and most importantly, funding, with the imminent reauthorization of MAP 21 coming up in May.

GAO Pedestrian and Bicycle Safety Study

After the briefing sessions, **Alyssa Reynolds Rodriguez** and I were asked by the Government Accountability Office (GAO) in Washington, DC to be part of a panel to provide input on pedestrian and bicycle safety. The GAO is conducting a study to look at safety issues and solutions used by various jurisdictions in North America. We shared our respective experiences and directed them to the many ITE resources.

State of the Institute

Executive Director and CEO **Tom Brahm**s gave an update of the state of the Institute with respect to finances, staffing, products and services.

The Budget/Finance committee has been reinstated and they met prior to the Board meeting to review the Institute's finances and budget and reported their findings to the Board. **Jennifer Rosales** is a member of that committee. The Institute now has an Integrated Accounting System that will provide e-commerce for membership dues, publications sales, professional development, ITE Journal and web advertising, exhibits, sponsorships, and meeting registrations. Quarterly financial statements will now be distributed to Section and Chapter Presidents with dues balances and scholarship fund balances, if applicable.

The Institute continues to get additional task orders from the U.S. Department of Transportation with a budget of more than a million dollars. In addition, ITE has a grant from South Coast Air Quality Management District and South California Data Collection Protocol Warehouse Trip Generation Study which is jointly funded by the two organizations for a total of \$50,000. This grant will commence with a panel meeting at ITE Headquarters on March 31.

There has been some interest for ITE to change its name, with the belief that it would expand our membership and make us more relevant. We must first ask ourselves, "Who do we say we are? And who would we like to be in the next 5 to 10 years?" If we desire to expand our membership to be more inclusive of others, we must decide who these others are and then reach out to them. This is only to begin a discussion as to what our brand should be. There will be many more discussions in the months ahead. If you haven't already done so, please send your suggestions to ideas@ite.org. The ITE Executive Committee, consisting of President Kennedy, Vice President Benway and Past President Neel, would like to have your input, especially as they prepare to select a new CEO of ITE this spring, as our past CEO of more than 40 years, Tom Brahm, prepares for a new chapter in his life.

Membership Services and Programs

The total voting membership is down by more than seven percent, or about 1,000 voting members. The majority of these were students who graduated and upgraded to Member and have not paid their 2014 dues. To date, headquarters has received 63 percent of the budgeted individual dues revenue.

Last year, the Board approved a new program to offer public agencies two options for paying member dues: a new flat rate for Governmental Agency members based on the jurisdiction's population, or the traditional option of paying dues based on number of members. For those public agencies that have selected the "flat fee" over their prior "stepped fee" dues, the result was a \$1,585 reduction in the amount paid. With a significant marketing effort to attract new public agencies, we should be able to generate greater revenue and exceed the budgeted

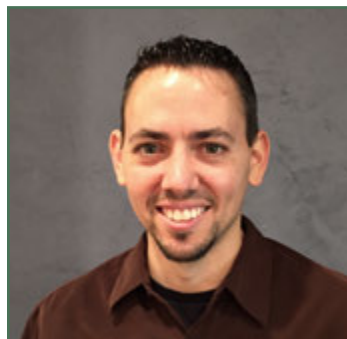

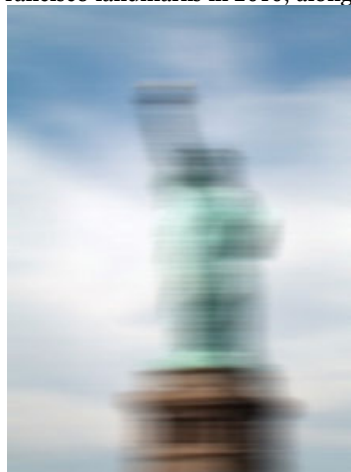
MiteY Race

amount. With several targeted membership drives, Flat Fee Agency Memberships, and “30 to 30” for Younger Members (annual dues are \$30 or less until the age of 30), the dues revenue should improve dramatically. Board Policies and Procedures Update

Updating the ITE Board Policies and Procedures was an initiative identified a couple of years ago and it is time to update this critical guiding document. The Board Policies and Procedures is a vital document that identifies the various steps to be taken by board members, CEO and Headquarters staff in various situations, governed by the International Board in the daily operations of the Institute. The committee’s primary objective is to update the Board Policies and Procedures to a level that it is relevant, effective and easily accessible to the International Board making this document user friendly. A committee, which includes **Alyssa Reynolds Rodriguez**, is busy working with a task force to accomplish this.

Coordinating Council

Under the Chairmanship of **Dr. Beverly Kuhn**, the Coordinating Council has begun implementing organizational changes approved by the Board. Primarily, the number of technical councils was dropped to six, with a new Complete Streets Council being formed. In the reorganization, several councils are now standing committees under related Councils. Information posted on the ITE Website has been updated to reflect these changes and simplified to provide a high-level overview to the public at large and to direct members to the ITE Community to learn more about discussion boards, products and documents developed by the council; events related to the council; and the Council blog. Links to the standing committees are provided for each, also directing members to the ITE Community.

Professional Development Program integration with Technical Councils

It is essential that our Professional Development program from year to year is coordinated and vetted through our subject experts in our technical councils. The Professional Development Committee is working with the Coordinating Council to enable this cooperation with ITE Headquarters. Every effort is being made to provide quality, relevant, value-added and timely webinars. As of March 5, 23 webinars have been conducted with an additional 89 pending. A “City Showcase” program is planned, using webinars to highlight what others are doing in individual cities.

LeadershipITE

ITE established the LeadershipITE program in 2013, recognizing that the future of great organizations requires the ongoing development of great leaders. This program was designed to identify, develop and engage leaders for the future of ITE and the transportation profession.

The intensive nine-month program is designed to facilitate the development and refinement of 21st century leadership and professional competencies; exploration of current issues in transportation; and enhancement of the professional network required to succeed as a leader within ITE, the workplace, and a broader community.

Michael Sanderson, Chair of the LeadershipITE Committee and visionary for this program, provided a brief overview on the success of the first year of the program where 30 individuals were in the 2014 inaugural class. He stressed that the focus needs to be on the next class, and critical fundraising efforts, to carry on the initial success of the program. Michael is serving an important liaison role between the

Alumni Committee and the LeadershipITE program with the new class of 2015. Three participants were selected from the Western District as part of the 20 young professionals of the Class of 2015: **Paul Barricklow** with Lee Engineering in Albuquerque, **Ashley Brooks** with Fehr & Peers in San Jose, and **Chuck Huffine** with Michael Baker in Lakewood, Colorado. They had their inaugural meeting in conjunction with the March International Board meeting at ITE Headquarters and many events were combined so the two groups could network.

Young Member and Student Member Initiatives

ITE has appointed a Young Member Committee to help identify ways in which ITE can attract and serve transportation professionals from their enrollment in transportation courses through age 35. Some of the initiatives that have been identified are:

- Discounted registration fees for ITE international meetings and conferences;
- Support of travel grants to assist young members to attend Section, District, and International meetings;
- Reduced dues for members 30 years old and younger (age 24 through age 30, membership dues increase incrementally, beginning at the low rate of \$30);
- Opportunities to engage and encourage young professionals to help address challenges and develop solutions;
- Inclusion of a young professional at International Board of Direction meetings; and
- Supported networking opportunities for young members such as Young Professionals in Transportation.

Young Member Drive

The District that sees the greatest percentage gain of young members (35 and under, non-students) between now and August 1 will be entered into a drawing for an iPad mini and showcased at the Annual Meeting in Hollywood, Florida. Get the word out in our Western District Sections and plan on plenty of friendly competition!!

Student Member Initiatives

The 2015 ITE Western District Student Leadership Summit was hosted by Sacramento State, in California, from Friday, February 13, through Sunday, February 15, 2015. More than 100 students attended, along with President Kennedy, Vice Presidential candidate **Shawn Leight**, Western District President **Carlos Ortiz**, Secretary-Treasurer **Mark Spencer**, and International Director **Jenny Grote**. Past President **Zaki Mustafa** and his family stopped by to cook a delicious BBQ lunch and serve all of us. He also shared his words of wisdom on the rewards of being involved in ITE, as a student and throughout our careers. The 3rd Annual Student Leadership Summit will be hosted by Cal Poly Pomona in February 2016, possibly in conjunction with the District’s Midyear Board Meeting.

Advocacy Committee

Last year, a new Advocacy Committee (AC) was appointed by then-President **Hibbett Neel** and chaired by **Monica Suter**. Their vision and proactive participation have accomplished the following:

Awards Committee

The Coordinating Council's Transportation Consultants Council initiated a new award for 2015 to be called the "**Distinguished Consultant Award.**" The award is intended to recognize outstanding contributions to the transportation engineering/planning profession and for service to ITE and/or the Consultants Council. The award recipient will be recognized at the ITE Annual Meeting Awards Luncheon, in the ITE Journal, and receive an inscribed plaque.

Another new award will be given on behalf of the Young Member Committee with the new **Rising**

Stars Program. This new "Rising Stars" award is intended to provide exposure and recognition for young members who are 35 years old and under. The primary objective is to create a robust and sustainable young member awards program to identify the next generation and new faces of the transportation profession. We want to create a culture of Young Member involvement and recognition at all levels of ITE and develop a recruiting pipeline for future LeadershipITE classes.

Miscellaneous items

ITE has developed a monthly membership payment plan as an option to paying annually.

The IRS has declined to recognize group exemptions for ITE as a whole, yet its chapters qualify for exemption individually. If the chapter income is under \$50,000, they are eligible to file a Form 1023-EZ and the filing fee for each is \$400. If income is more than \$50,000, then Form 1023 is required and the cost is \$850. More information is forthcoming on how Headquarters will proceed and who will pay the fees.

Status of the Transportation Professional Certification Board (TPCB) - the TPCB Board has a new Chairman, **Ken Ackeret**; a new Vice Chairman, **Michael Parks**; and a new Board Member, **Earl Newman**.

A China Initiative Task Force was asked to examine opportunities for the possible recruitment of high school student members of transportation clubs in China. Task force Chair is **Eva Lerner-Lam** and members include International Director **Don McKenzie**, **Shawn Leight** and me.

Strategic Planning Committee - A new initiative is underway to focus on the Institute's Strategic Plan, specifically a 5- to 10-year plan, with a committee chaired by Vice President Paula Benway.

Fall 2015 conference at the Westin La Paloma Resort in Tucson, Arizona, October 28-31 - This meeting will replace the traditional ITE spring technical conference and exhibit. Events at this meeting will include a golf tournament to support the LeadershipITE program.
